COVID-19 Protocols/Conditions for Use for the CIH Arena

Your health and safety is our first priority. We have been working closely with the Eastern Ontario Health Unit in order to ensure that we can all return to play safely. It is now everyone's responsibility to ensure safety by following these protocols.

With the exception of Public Skating, it is the responsibility of the contract holder to ensure that all participants are aware of and adhere to these conditions.

1. **All individuals will need to complete** an online assessment prior to entering the facility, which is available at the link below or on our website under COVID 19.

 - a. The following individuals are **not** permitted to enter the building or participate in the ice rental:
 - i. Anyone who is sick or has any of the following symptoms: fever, cough, sore throat, runny nose, shortness of breath, difficulty breathing, headache.
 - ii. Anyone who has recently returned from travelling outside of Canada, in the past 14 days.
 - iii. Anyone who has knowingly been exposed to or been in contact with anyone who has tested positive for COVID-19, in the past 14 days.
 - iv. Anyone who does not pass the screening questionnaire
2. Any person who enters or uses the facility must maintain a physical distance of at least 2 meters from any other person who is using the facility. **All individuals must wear a mask at all-times inside the facility.** A mask is required in the dressing room and between the room and the ice surface, but is not required when on the ice. Anyone using the walking track is required to wear a mask while walking.
3. **SPECTATORS:** Parents are not allowed in the dressing rooms. Spectators are to remain in the ice pad area (dress warmly) and are **NOT** to be wandering around the arena hallways/lobbies at any point during the rental, and are to **leave and wait outside for their child to exit after the rental.** All spectators are required to follow protocols.

5. Change rooms will be assigned with a limited capacity of 13 per room. Special requests for rooms are not available and no changes are permitted. It is recommended that participants arrive ready to play as much as possible, showers be accessible at 50%. Participants will have access to the building/dressing room **15 to 30 minutes** prior to their booking and must vacate the building **15 minutes** after their booking. **NO LOITERING** is allowed anywhere in the building.
6. Activity organizers are to take attendance for each date on the contract and for each group accessing the space during the rental period and **records must be kept for twenty-one days (21)** for the purpose of tracing in the event of a COVID-19 outbreak.
7. Players are encouraged to bring their own equipment. Equipment being used during the practice should not be shared between players. Any shared/team owned equipment must be sanitized between each use. Sanitizing products must be provided by the **contract holder**.
8. **DURING THE ACTIVITY**
 - **DO NOT** spit
 - **DO NOT** blow your nose without a tissue or paper towel
 - **DO NOT** remove any equipment – full equipment (including player gloves) must be worn at all times.
 - **DO NOT** touch any equipment (ex. Cones) unless instructed to do so by a coach/instructor
 - **DO** label water bottles clearly with the participant's name, and leave the water bottle in the designated area.
11. These conditions of use must be followed at all times; failure to comply may result in immediate removal from the facility, non-refundable ice cancellation and review of future contract bookings.
12. All individuals must comply with all current EOHU recommendations and directives related to COVID-19. Please visit www.eohu.ca to learn more.
